Movimiento de Recuperacion Revolucionaria  
(MRR) (Revolutionary Recovery Movement)

MM T-8, a Cuban exile, who is an officer of the MRR, on August 12, 1965, advised that the MRR continues activity in propaganda efforts against the Government of Cuba. However, the organization does not have any military training camps or activities, and MANUEL MARTINEZ BUESA continues as the head of the MRR. (U)

On July 30, 1965, MM T-2 advised that HERMINIO DIAZ, a Cuban exile who has a reputation as a gunman, is working with a group of MRR members. Among persons in this group are SANTIAGO ALVAREZ, SANTIAGO ALVAREZ, JR., and MIGUEL IZA, all of whom have experience in arms, boats, and raids. The group was then considering either a raid against Cuba, or an attack against Cuban shipping. (U) *Cuba*

MM T-2 on August 23, 1965, reported that the group had not decided on what course of action to take. They have arms they retained from a couple of years ago. They say if they do not develop some military action, they will sell the arms to some other Cuban anti-CASTRO groups in Miami. (U)

Cuba Libre (Free Cuba)

*Cuba*  
Cuba Libre is a small, closed group of activists headed by CARLOS ZARRAGA MARTINEZ, 2954 S. W. 16th Terrace, Miami, whose home is used as headquarters for the group. (U)

On September 7, 1965, MM T-3, who is closely associated with this group, advised that ZARRAGA and his associates left the Florida Keys in a twenty-five-foot motorboat for an infiltration mission against Cuba on August 30, 1965. About twelve miles off the coast of Las Villas Province, the boat developed mechanical trouble, and had to return to Florida the following day. The mechanical trouble developed when one of the infiltrators aboard test-fired his gun and accidentally shot out the steering mechanism of the boat.
