It is noted Bureau tel to Chicago, May 21, 1963,
concerning PAULINO SIERRA, instructed the Chicago Office
to ascertain from SIERRA the scheme in which he and
TRULL are involved. TRULL appears to be identical with
the unknown American mentioned in attached letterhead
memo, but persons in Miami do not know his name.

Inasmuch as SIERRA and TRULL have been unsuccessful
in their attempt to establish a unity movement, the
Miami Office will hereafter follow this matter under the
Anti-Racketeering investigation.
