On 12/16/59 SAS EDWIN D. KUYKENDALL and KENNETH C. HOWE received a typewritten report from DL-7-S, dated 12/14/59, which has been serialized as 134-4A-303A:

Informant determined the regular meeting of the Dallas CP took place at 1123 Ballard Street, Dallas, on 12/14/59. Present were BILL and RUTH LOWERY, JOE LANDIN and AUGUSTIN ESTRADA.

Informant determined the group discussed the Young Democrats organization. BILL LOWERY, who had spoken to one of the Young Democrat members, reported a Dixie-crat had donated some funds to the Dr. WILLIAM ANDREW faction. Some of the funds had been used to pay some of the new members dues and to pay for the bus that was chartered for the National Convention. The Dixie-crat, BILL added, is with Lone Star Steel.

GONZALEZ and ANDREW have recruited a number of Latin-Americans for the Young Democrats. They have paid some of these members' dues. While they were not told of the real issues in the organization, they have been asked to support Dr. ANDREW's side. The other faction had FRANK MEDRANO call most of the new recruits and tell them what they are getting into. PAULIA WEAVER told BILL LOWERY that MEDRANO did a good job.
