Informant advisor that a regular CP meeting was beld at the home of JOH LANDIN on 2/0/60, and that JOH and MANGAREY LANDIN, DILL LOWERY and ANGUSTIN ESTRADA were present.

At this meeting Dill LOWERY reported that he had attended a meeting on Friday, 2/5/80, which was beld at a church on Calland and Forest, and that most of the participants represented some organization. Informant stated he learned that these individuals not there to form an organization that will enter a Negro emplicate to file at the leas minute. They think that by doing this they may easth the racists off guard and thus ward off a big white vote against their condidate. Their meet meeting will be 2/19/50.

ELHOID ROSS, who had lovited BILL LOWERY to the meeting, was 111 and did not attend the meeting. BILL LOWERY informed the group that the American GI Forum was having a district meeting at the Baker Notel, Cunday, 2/14/50.
