On March 29,1960, DOMINIC D. BILOTTA, Manager, Shannon Life Insurance Co., 1216 No. Houston, Fort Worth, Toxas, advised that JESS ALVAR-Z had attempted to accuse Mr. SHANNON with discrimination against Latin Americans, but that he had not been able to make the charge stand up. Mr. BILOTTA furnished substantially the same information as furnished by OLIVER SHANNON. He advised that the three men who came down with JESS- ALVAR-Z were MANUEL JARA, 3514 No. Harding, who is omployed at Snelson Printing Co, 2719 Race St., Fort Worth. He was a member of American G.I. FORUM, and is described as Mexican male, age 40-45, 5! 8", 140-150 pounds.

A second man with ALVAREZ was HAROLD VALDAROS, an attorney, 6141 Karen Cir., Fort Worth; described, male, age 40-45, 5' 6", 135-140 lbs.

The third man with ALVAREZ was M.B. BARAGHAS, Chairman of American G.I. Forum, with residence 2913 Townsend Dr., Fort Worth. He is described as Mexican male, age about 50, wears glasses, has round face, 5'8", and 170 lbs.
