On 4/12/60 DL-7-S, who has furnished reliable information in the past, made available to SA W.HARLAN BROWN a typewritten report dated 4/12/60 concerning a Dallas CP meeting held on 4/11/60 at the home of BILL LOWERY, 1123 Ballard Street, Dallas, Texas. The original report is filed as 134-4A-321.

Those present were BILL and RUTH LOWERY, JOE and MARGARET LANDIN. AUGUSTIN ESTRADA was absent.

BILL reported that he had recently contacted HAROLD MANN and his wife. BETTY, an ex CP member, and HAROLD, also a former CP member, live in Marshall, Texas, but HAROLD works in Fort Worth with his brother as a plumber, BILL LOWERY reported. Informant also determined that HAROLD would not re-register as a CP member and BILL LOWERY was quite sure that Mrs. MANN would not. BILL and HAROLD visited a CP member in Fort Worth named MC KINNEY who is willing to re-register and who purchased \$2 worth of Marxist literature from BILL. MC KINNEY said he was willing to meet with Dallas CP members and would arrange a meeting for the coming Friday night. BILL and JOE were to let AUGUSTIN know of this development.
