On 5/4/60, SA JAMES P. HOSTY, JR., received a written report from DL-7-S in person, which report is dated 5/2/60, and has been serialized as 134-4A-324.

Informant advised he learned that a regular CP meeting took place at the home of JOE LANDIN on Monday, 5/2/60, at 8:30 PM. Those present at the meeting were MARGARET and JOE LANDIN, RUTH and BILL LOWERY, and AUGUSTIN ESTRADA.

Informant said BILL LOWERY made a lengthy report on the Marshall story. He had attended a meeting at the New Hope Baptist Church on Sunday, 5/1/60, and it was there that he heard the students of Marshall, Texas, who took part in the sit-in protests give their version of what took place.
