On 7/8/60, DL-7-S, in person, furnished a typewritten report to SA W. HARLAN/2 Which report has been serialized as 134-4A-330, and is dated 7/5/60.

That report stated that on Tuesday, 7/5/60, BILL LOWERY telephoned JOE LANDIN at his home. LOWERY had received a letter written in Spanish from G. I. Forum founder, DR. HECTOR P. GARCIA. LOWERY wanted help in translating the letter into English and asked JOE to help him.

It was stated in the report that the letter related to a case in Rivera. Texas, where a State patrolman had shot and killed a Latin in altercation. The Latin-American had refused to sign a speeding violation ticket. The killing occurred in the victim's yard, a few feet from his front door, and in the presence of his wife, his mother, and 15-year old brother. The victim, VICENTE TREVINO, is survived by his wife and five children under six years old, and MRS. TREVINO is expecting another child.

The report further reflects that DR. GARCIA heads a statewide VINCENTE TREVINO MEMORIAL COMMITTEE and urges the Chairman of the Dallas Forum to contact other organizations and form a VINCENTE TREVINO MEMORIAL COMMITTEE. He suggested that such a committee should be formed in every Texas town. GARCIA outlined some things the committee should do.

After receiving JOE LANDIN's assistance in translating the letter, BILL LOWERY said he would take the letter to the Forum meeting that night.
