On 7/21/60 SA JAMES P. HOSTY, JR., received a handwritten report from DL-6-S, dated 7/22/60. This report has been serialized as 134-1A-531.

Informant determined that on 7/22/60 BILL LOWERH phoned JOE LANDIN and wanted to know if he could come over for their regular CP meeting. JOE LANDIN told him to make it someother time because they were expecting company.

BILL LOWERY told JOE LANDIN a little about the forum meeting which took place on 7/21/60. The committee set up to help in the memodal of VINCENT TREVINOhad not done anything and he had it dissolved and appointed a three-man committee to contact other organizations and try to form the Trevino Committee. LOWERY saemed thoroughly disgusted and threatened to quit the forum and do something on his own about the TREVINO case. He used violent language in criticizing the "don't care" attitude of the forum. The TREVINO case, LOWERY said, was treated very lightly. He stated he got mad at the meeting and made most of the members mad at him because he insisted they do something about the case. It seemed that only three or four persons wanted to do something about it. Mrs. ROBERT H. JONES was one of them, and JOHN LANDIN, a non-member was another. Informant determined that JOHN LANDIN was present because he wants the forum to sponsor a dance for him.

Informant determined that BILL LOWERY severely criticized JOE MOLINA who is opposed to doing anything for TREVINO. In the past, however, LOWERY and MOLINA have worked hand in hand and this was their first disagreement.

Informant could furnish no additional information.
