On 8/9/60, SA W. HARLAN BROWN received in person a handwritten report from DL-6-S, dated 8/8/60, which has been serialized as 134-1A-534.

That report stated a regular CP meeting was held at JOE LANDIN's house, and those present were JOE LANDIN and BILL LOWERY. MARGARET LANDIN, RUTH LOWERY and AUGUSTIN ESTRADA did not attend. JOE LANDIN explained his wife MARGARET LANDIN had been invited to attend a shower for one of MRS. ESTRADA's nieces.

At this meeting, BILL LOWERY, according to informant, repeated the story of how he quit the Forum's chairmanship. He reported that he had spoken to GILBERT GARCIA, Forum State Chairman. GARCIA had approved his resignation, saying that now perhaps they (Dallas Forum) would do something about the TREVINO case, and if they did, he urged BILL LOWERY to by all means go back to the Forum, that is to be active again, as BILL LOWERY quit only as chairman, and is still a member.

According to informant, BILL LOWERY reported that he had contacted NATALIE and ELWOOD ROSS and wanted to form a committee, an anti-curfew committee, opposing the pro-curfew committee that is just emerging. The ROSSSES, BILL LOWERY said,
