On 8/17/60, DL-7-S furnished in person to SA W. HARLAN BROWN a typewritten report dated 8/8/60, which has been serialized as 134-4A-335.

That report reflected a regular CP meeting was held at the home of JOE LANDIN. Those present were JOE LANDIN and BILL LOWERY. BILL LOWERY retold JOE LANDIN about his resignation as Forum Chairman; that he has also spoken to GILBERT GARCIA and GARCIA thought LOWERY had done the right thing by resigning his post, but urged him to be active in the Forum, especially if they decide to do something about the TREVINO killing. LANDIN and LOWERY did not think this was probable.

BILL LOWERY also reported that he had contacted AL and NATALIE ROSS and sought their help in forming an anti-curfew committee to oppose the pro-curfew committee that is allegedly being formed. LOWERY said the ROSSES were cool to the idea, and they believe the curfew is a passing thing.

The report further reflected that JOE LANDIN had reported he had done some mimeographing for the NAACP Youth Council, which was the program that was presented by the Youth Council. LANDIN gave BILL LOWERY a copy of the program. JOE LANDIN also reported that he had received a gift from the Council, a gold NAACP lapel pin. He stated he would not wear it at the present time, he felt it was dangerous to display, and BILL LOWERY agreed.
