On August 17, 1960, DL-6-5 furnished in person to SA W. HARLAN BROWN a handwritten report, dated 8/8/60, and which has been serialized as 134-1A-537.

That report reflected BILL LOWERY photo JOE LANDIN on Monday afternoon, 8/8/60, and asked him to postpone their regular Monday night meeting until Wednesday night as he wanted to attend the G.I. Forum meeting, 8/9/60, and submit a report of the G.I. Forum to the CP meeting Wednesday night. LOWERY asked LANDIN to contact AUGUSTIN ESTRADA and tell him of the postponement.

The report reflected JOE LANDIN did call AUGUSTIN ESTRADA and gave him LOWERY's message. AUGUSTIN ESTRADA advised LANDIN he would attend, and added that he had something to show them.
