On 4/26/61, DL-7-S furnished a typewritten report to SA W. HARLAN BROWN, which report was dated 4/12/61, and has been serialized as 134-4A-372.

That report reflected that on 4/11/61, JOE and MARGARET LANDIN lunched with AUGUSTIN ESTRADA. LANDIN brought ESTRADA up-to-date on his activities and mentioned that he would be able to meet with him and BILL LOWERY on a weekly basis. JOE LANDIN said this was now possible because the elections were over.

Informant determined that AUGUSTIN ESTRADA said he was expecting Fort Worth CP member MC KINNEY to visit him any night now; that MC KINNEY had marital troubles, he had remarried and his present wife was supposed to be a Negro from Panama. He later found out that she was not a Negro and has told MC KINNEY that she "likes to shoot Negroes."

ESTRADA further stated that BETTY and HAROLD MANN have told him and BILL LOWERY personally that they will not work with the CP. BETTY MANN had burned some CP reading material that LOWERY had taken them. ESTRADA said he had learned that HAROLD MANN has been working with G.I. Forum State Chairman GILBERT GARCIA. MC KINNEY has also worked with GARCIA. ESTRADA reported that RICK LIMERICK is very active in the ADA and other organizations.

Informant had no additional information.
