On 2/5/64, SA W. HARLAN BROWN received, in person, a handwritten report, dated 2/3/64, from DL-6-S, which has been serialized as 134-1A-814.

Informant determined on 2/3/64 that on that date AUGUSTIN ESTRADA and JOE LANDIN met for one hour during their lunch period. LANDIN reported on his activities, he told ESTRADA that FRANK MEDRANO was starting a club in March. The club will consist of married couples. He and LANDIN felt that this club would be much more active than the Forum or PASO. MEDRANO has already nine couples he can count on. The club will be called Educational and Social Club. Its function will be to discuss various subjects, from politics to hootnannies, and to participate in local community projects. A different couple will be chairman and vice chairman each month. This will give the members a sense of belonging, a sense of participation and a greater interest in the club.

MEDRANO, LANDIN said, had recently spoken to Mrs. REED (who picked St. Paul). Mr. REED, an employee of the Dallas Public Library, had requested by letter of library officials that more Negroes be hired - especially in mobile libraries. She received an answer which she thinks expressed a white-supremist attitude. The letter states, among other things, that it wouldn't look right for Negroes to have such a position since they would be dealing with white people. Mrs. REED has saved the letter as evidence and thinks the library ought to be picketed.

MEDRANO, LANDIN recalled, had mentioned that A. P. CALDERON had burned some handbills that MEDRANO had given him. He burned them because the handbill read something like this:

"MEDGAR EVARS, President KENNEDY and four little innocent little girls gave their lives, will you give your vote?"

CALDERON did not approve of EVARS being listed first. Nobody, he said, could take his President's place, he had met the President, he knew him.

LANDIN said he had recently spoken to ALBERT OROZCO, G. I. Forum member. OROZCO had told him that people were not joining the Forum because of what had happened to ex-Forum member JOE MOLINA.

In the meantime, LANDIN added, EDWARD MYCUE (who picketed St. Paul) had visited him on Saturday and invited him to the Catholic Interracial Council meetings. MYCUE wanted to do something about the special law enforcement officers who are "murdering" burglars with shot guns. LANDIN told him he would talk to MEDRANO and see what he thought about the subject. MYCUE, who is a bright intelligent fellow, full of facts and figures on many a subject, told LANDIN that his sister's doctor had terminated his patient-doctor relationship because a Negro boy visited her while she was sick at St. Paul Hospital. MYCUE has also been relieved of his executive post at the Catholic Interracial Council and has been asked to resign from his job.
