Former associates at the Office of Government Reports regard appointee as loyal American. Navy service verified--nothing unfavorable. Neighborhood investigations reflected nothing unfavorable regarding loyalty. Files of Security Division of Department of Commerce contain no additional pertinent information. Files of Investigations Division, CSC, contain nothing unfavorable regarding appointee. Nothing derogatory regarding appointee in files of Washington, D. C., Credit Bureau, and no record of him in files of ONI, MPD-DC, or HCUA.
