CSC has now made the following request of the Bureau on CSC Form 3746: "FBI Memorandum dated 6-4-65 states an FBI source advised one Julia Cellini had a business connection with Edward K. Moss, reportedly a pervert." Can the FBI disclose to us the identity of this source?"

The information on which CSC request is made appears on page 2, paragraph 2, of referenced memorandum. Referenced airtel indicates the source involved is WF 1086-C.

WFO determine if source is willing for his identity to be disclosed to the CSC as the source of this particular information and whether WFO would concur in this matter.
