(UC) (Cuban Units) as another title by which the ELC is known.

captioned, "UNIDADES CUBANAS MILITARES, aka., IS - CUBA,"
(Bufile 109-584) (Savannah 105-750) (Miami 105-7898.)

Enclosed for the Bureau are 14 copies of letterhead
memorandum dated and captioned as above.

MM T-1 therein is DOMINGO ECHEMENDIA,
PSI (Under Development) of the Miami Office.

From the letterhead memorandum, it is evident
that the ELC and UNIDADES CUBANAS are actually one and the same.
Inasmuch as the ELC is reported to be inactive and in a state
of dissolution, instant case is being closed by the Miami Office

By separate letterhead memorandum, data concerning
the UNIDADES CUBANAS MILITARES is being submitted.

A copy of instant letterhead memorandum is furnished
to the Savannah Division, so that it may be apprised of the
fact that no further investigation is being conducted at Miami.
However, Savannah will be furnished information obtained con-
cerning UNIDADES CUBANAS MILITARES, inasmuch as this office
was previously furnished a copy of re Miami letter.
