Fla THE UPI SOURCE IS FRANK EIDGE, UPI HEAD, HERALD BUILDING, MIAMI. TODAY EIDGE RECONTACTED AND HE ADVISED THAT THE INFORMATION CONCERNING RADIO RELOJ MENTION ON MORNING APRIL 26 OF RORKE'S BOMBING ATTACK ON HAVANA WAS BASED UPON SECOND HAND REPORTS RECEIVED FROM CUBAN EXILES IN MIAMI AREA. UPI WAS UNABLE TO MONITOR RELOJ AT THAT TIME.

EIDGE STATED THAT ABOUT 7:45 PM APRIL 26 THE ASSOCIATED PRESS PUT OUT A BULLETIN THAT RADIO RELOJ HAD CONFIRMED THE RAID.

BETWEEN 10 AND 10:30 PM SAME DAY UPI RECEIVED REPORTS FROM CUBAN RADIOS CMQ AND PROGRESO CONFIRMING RAID.

(u) *(S)* [MM 492-S] WAS MONITORING CUBAN RADIO STATIONS RELOJ, CMQ AND UNION FROM 11:55 AM TO 4:30 PM APRIL 26 AND HEARD NO MENTION THIS RAID. HOWEVER, THAT SAME EVENING [MM 492-S] *(u)* HEARD CUBAN RADIO BROADCASTS ANNOUNCING THIS RAD. INFORMANT NOT CERTAIN AS TO EXACT TIME OF BROADCASTS AND STATIONS INVOLVED, AND IS ATTEMPTING OBTAIN MORE SPECIFIC DATA. [MM 492-S] IS A CUBAN EXILE WHO LISTENS TO MANY CUBAN BROADCASTS AND HE HAS GOOD CONTACTS WITH CUBAN EXILES IN FIELD OF COMMUNICATIONS. *(u)*

MIAMI WILL ADVISE FURTHER DEVELOPMENTS.
