In August, 1945, FREEDMAN was the doorman and the manager of the Cloverdale Social (gambling) Club, 734 South Cloverdale Avenue, which club was owned by RUFFY GOLDBERG and MAURICE MEDLEVINE, alias Frenchy.

JIMIY GARRISON, real name James Albert Garrison Los Angeles County Sheriff's Office #4-32161

As previously mentioned in the sention, entitled "Organized Gangs" concerning the Kansas City Gang, GARRISON is a bookmaker, operating in the Horseshoe Cafe, 13828 Ventura Blvd., North Hollywood, and is a known contact for Kansas City hoodlums in Los Angeles.

*MAURICE C. GAULT Los Angeles Police Department #62163

C.I.L.A. 3075 advised that GAULT is presently handling all of the book-making operations in Paramount Motion Picture Studio in Los Angeles and that everyday at Noon he appears at instant studio with large sums of money, amounting to over \$20,000.00 in cash in order to effect the proper pay-offs. C.I.L.A. 3095 advised that GAULT originally came from Chicago and knows all of the bigtime hoodlums from Chicago. He is a personal friend of FRANKIE FROST, the gambler in Reno, Nevada. This individual is known to frequent Mike Lyman's Restaurant in Hollywood.
