Iran & Israel

Enclosed for the Bureau are seven copies of a letterhead memorandum (LHM) setting forth information concerning LEO MEYER OGUL.

The Bureau is requested to cause investigation to be conducted in Iran and Israel through the U. S. Department of State. Investigation is being requested in both countries inasmuch as OGUL has passports good for travel in each country, and he has allegedly been in both Iran and Israel recently.

A lead is currently outstanding for Washington Field to review the passport files of U. S. Department of State for OGUL, and to attempt to determine what problems OGUL had with the U. S. State Department.
