Synopsis of Facts:

Confidential Informant PHT-19 reports WILLIE WEISBERG in almost daily communication with HARRY STOLBERG, alias NIG ROSEN, New York racketeer, and is personally visited by WEISBERG in New York City at least once each week, these visits on occasions occurring even more frequently. Information developed from this source disclosed a close relationship existing between NIG ROSEN, WILLIE WEISBERG, and MARCO REGINELLI, Camden, New Jersey racketeer, and personal meetings with these three individuals taking place at the SCIAMANNA CAFE, 4th and Royden Sts., Camden, N.J. One JULIUS FINK of Baltimore, Md., previously identified as an associate of long standing of WEISBERG, continue in their close relationship in business matters of an undisclosed nature. Other out of state interests of WEISBERG connects him with LOU KINGIE (ph.) Washington, D. C., also DAN WALPER and JACK LEWIS of Chicago, Ill., and SAMMY KANE (ph.), Miami, Fla. Confidential Informant PHT-19 submits information with respect to the business association of WEISBERG with JOHN DEYCHAS and JOHN WACKETT, both police officers of Phila. P.D., the latter two individuals serving as a "front" for WEISBERG and SAMUEL "CAPPY" MOFFMAN in the operation of MOTOR SALES, INC. of MEDIA, PA. No current
