Since Senator FARLEY is reported to have stock in the Atlantic City Race Track, according to NK 1724, the conclusion reached by Captain FARLEY, his brother, may have some credence. The anonymous caller told Captain FARLEY that a JOHN MARTINO was working for MILITE and that VINCENT and MICHAEL MARTINO, John's cousins, did not want to be associated with JOHN.

According to a news article in the Atlantic City Daily World of February 24, 1948 and according to NK 1724, LOUIS MILITE was in Senator FARLEY'S company at a party given by MIKE FICRI, vice president of the Atlantic City Race Track Association.

In connection with VINCE MARTINO mentioned above, 1724 advised that VINCE was an attorney for a health clinic in Washington, D.C. from about 1942 to 1945 but had to leave that city due to an investigation of vice conditions conducted by the Bureau. He returned to Atlantic City, and it is noted that a new health clinic has been started by one AGNES STEIN, a former notorious madam and a Dr. NATHAN TARGAN at 127 North Arkansas Avenue, Atlantic City, New Jersey. This was the address of AGNES STEIN'S notorious house of prostitution in the 1930's.

VINCENT MARTINO may have some connection with this establishment according to 1724. In connection with another investigation, the Resident Agent of Atlantic City had occasion to talk with Dr. TARGAN at his place of business at 127 North Arkansas Avenue; and observation disclosed that it is an elaborate setup and that the waiting room was filled with young women between the ages of 20 to 30. No male patients were observed in the waiting room, and Dr. TARGAN appeared very nervous during the interview.

## C. POLITICAL TIE-UPS MITH ORGANIZED CRINE

This situation, according to NK 1724 and 1725, has not changed in the last three years. Senator FRANK FARLEY is still the Republican leader of Atlantic County. His car is observed regularly by the Atlantic City Resident Agent at the Cosmopolitan Club, the owner of which is HERMAN (STULPY) ORMAN. ORMAN and RALPH GOLD, both close associates of FRANK FARLEY, are the liaison for the politicians and Atlantic City racketeers.

Both CI 1724 and 1725 have been attempting to force police action against organized crime through newspapers and radio talks. The Atlantic City Press, a daily publication has always given space to 1724 and 1725 and has been independent and fearless in reporting the news.
