On 5/18/60, LESTER WOLFE, moderator of TV program "Between the Lines", New York City, NY, advised that he is preparing a program on the Cuban situation to be televised Sunday, May 22, 1960, on Channel 13, WNTA, Newark, New Jersey.

WOLFE is having as participants Dr. CHARLES SANTOS BUCH, 1315 York Avenue, New York City, as pro-CASTRO, and STANLEY ROSS, editor of "El Diario de Nueva York", as anti-CASTRO. ROSS will be assisted by his assistant whose name WOLFE could not recall. (Possibly RAUL ACOSTA RUBIO, reporter on "ROSS' newspaper, former editor of "El Imparcial of Puerto Rico and who is the former private secretary of FULGENCIO BATISTA.)
