The report of SA MAURICE F. FARABEE, dated March 28, 1961, at Miami, in the case entitled "Changed, GUILLERMO FEDERICO COLOMA Y ENRIGUEZ, aka, IS - Cuba, RA - Cuba," reflects that DOMINICIS was interviewed by the Miami Office on February 15, 1961, concerning FRANCISCO RODRIGUEZ TAMAYO, aka, "El Mexicano," the subject of Bufile 105-78976, Miami file 105-1891, and concerning GOLOMA.

On the basis of the information reflected in instant report, no additional information is deemed warranted by the Miami Office. DOMINICIS is believed to possess insufficient potential to warrant his development as a PSI; therefore, this case is being closed by the Miami Office.
