HANARD is also currently cooperating with the Miami Office in a case involving CHARLES KARPF, a racketeer who has recently been charged with receiving stolen goods consisting of \$50,000.00 worth of stolen bonds.

For the information of the Bureau, HANARD is regarded locally by law enforcement agencies as a somewhat unscrupulous private detective. He has a penchant for newspaper publicity. He is a "name dropper" and indicates to his acquaintances that he has good connections with all law enforcement agencies in this area. At the same time, it is suspected by some law enforcement officials that HANARD might be engaged in blackmail and other similar practices through operation of his detective agency.

It is believed that in this case, HANARD has no actual intention of ever launching an expedition to Cuba, and that he is using this organization, the Freedom Fighters of the Americas, as a means of obtaining publicity and enhancing his own importance. It appears that this organization is in the process of "dying on the vine".
