Reference is made to Miami letter October 7, 1958, to the Bureau (Bureau file 97-3243) entitled "JULY 26 CLUB OF NEW YORK, aka.; FPM - CUBA; RA", with copy to New York, which stated in part, "On September 21, 1958, MM 639-S advised that ANGEL PEREZ VIDAL, July 26 Member, New York City, was in Miami and stated that a Cuban pilot was sent to the U. S. to spy on the July 26 by the Cuban Government; that he was found out by the July 26; they took a signed statement from him, and that they were going to turn this information over to the Federal Government in New York City. Informant said that some of the members of the O/A (Authentic Organization) wanted to kill this pilot, but PEREZ intervened, stopped them, and said it was better that the U. S. Government know about his position then, than taking action against him." It appears that this information may relate to ORGANVIDES in view of the time element, and that it may lend some credence to ORGANVIDES' allegation to Mr. HERNANDEZ. X(u)
