Although this case is being placed in a closed status, the Miami Office is continuing its investigation of the case entitled, "CARLOS PRIO SOCARRAS, ET AL; FPM-CUBA; REGISTRATION ACT", and this Office will continue alert for any information relative to the "RESISTANCE COMMANDOS". It appears that the "RESISTANCE COMMANDOS" may be primarily a figment of ORTEGA's imagination, created for the purpose of keeping BATISTA off balance through propaganda prepared by ORTEGA as described in this report.
