ReWFOlet to Bureau dated 2/15/61, captioned as above reflecting that RAMIRO LOYS, WFCS, would leave Washington, D. C., 2/16/61, for Miami for a scheduled appointment with TONY VARONA, co-ordinator of the FRD. ~~(u)~~

Enclosed herewith for the Bureau are four copies of a letterhead memo and two copies for Miami.

On 2/28/61, LOYS voluntarily appeared at the WFO and was interviewed in Spanish by SAs PHILIP T. KING and JOHN L. SPURGERS, JR. and furnished the information contained in letterhead memo. ~~(u)~~

LOYS advised he registered at the Lيامington Hotel, 2/16/61, and visited the FRD offices in Miami on 2/17/61. ~~(u)~~

Four copies of the attached letterhead memo are being sent to the Bureau, one of which is for the "CLIP" file since information contained in letterhead memo refers to the U. S. Government backing of the FRD. ~~(u)~~

The letterhead memo is classified "Secret" since unauthorized disclosure of this data could result in serious damage to the U. S. and could have a bearing on our national defense. In addition, unauthorized disclosure of the information contained in the memo could result in the identification of the source and could possibly compromise his future effectiveness thereof. ~~(u)~~
