has previously been reported VICTOR EMANUEL PEREIRA and EUGENE BRADING wa. JAMES BRADLEY LEE both received twelve year sentences in United States District Court, El Paso, Texas, in January, 1952 on charges of defrauding Mrs. GERTRUDE J. JOYCE of Roswell, New Mexico out of approximately \$49,000.00.

On June 26, 1952 DADE M. CAREY was., a PCI of this office, reported that PEREIRA was in Denver and had been in touch with him. He stated that PEREIRA is now going with Mrs. LEE LITTLE of Dallas, Texas, widow of the late LEE LITTLE, who was a multimillionaire, Texas oil man. He stated that LITTLE formerly owned the Magnolia Oil Co. and had headquarters in Dallas. CAREY stated that Mrs. LITTLE is madly in love with PEREIRA and had recently purchased for him a 1952 Cadillac fleetwood sedan, which PEREIRA is now driving. He further stated that BRADING had recently been in Denver with PEREIRA and Mrs. LITTLE, but had a few days previously gone to Dallas, Texas.

On June 27, 1952 CURTIS ROBERT WAGNER, a PCI of this office, reported that he had just been in conversation with PAUL AUGUSTUS KING was., gambler and confidence man known to be a close friend of PEREIRA and BRADY. He stated that KING told him that PEREIRA is presently in Denver, Colorado with Mrs. LEE LITTLE of Dallas, Texas, who is the widow of the late LEE LITTLE, a multimillionaire Texas oil man. KING told WAGNER that it is his understanding that Mrs. LITTLE now is madly in love with PEREIRA and desires to give him \$50,000.00 with which to go into the oil business.
