VICTOR EMANUEL PEREIRA, WAS. ET AL. ITSP, MAIL FRAUD, CONSPIRACY. CO-EL PASO.
DN 123-C REPORTED VICTOR PEREIRA ATTEMPTED TO CONTACT HIM IN DENVER JUNE 8, 1953. INFORMANT NOT IN AT THAT TIME BUT PEREIRA PERSONALLY TALKED TO INFORMANT'S WIFE AND SAID HE JUST ARRIVED IN DENVER AND EXPECTED TO BE HERE SEVERAL DAYS. HE SAID HE LEFT EUGENE BRADING, MRS. PEREIRA AND MRS. FRANKIE HARNELL IN EITHER DALLAS OR FORT WORTH, TEXAS. DN-123-C SAID PEREIRA WAS REPORTED ASSOCIATING WITH ARTHUR LEWIS CLARK, WAS. FBI 3709258, PREVIOUSLY DESCRIBED IN THIS CASE AS MIAMI, FLA. GAMBLER, WHO IS PRESENTLY IN DENVER. DN-119-C REPORTED JUNE 8, 1953 THAT ARTHUR LEWIS CLARK NOW REGISTERED ROOM 510 COSMOPOLITAN HOTEL, DENVER, WITH ROGER L. BAUMAN, PREVIOUSLY DESCRIBED IN THIS CASE AS DALLAS, TEXAS, INDEPENDENT OIL OPERATOR. INFORMANT STATED PEREIRA ALSO REGISTERED AT COSMOPOLITAN HOTEL IN ROOM 710 AND ASSOCIATING WITH CLARK. REGISTRATION OF PEREIRA AND CLARK AT COSMOPOLITAN HOTEL VERIFIED. FOR INFORMATION OF DALLAS, BUREAU AND EL PASO, HAVE REPORTED TWELVE YEAR CONVICTIONS OF PEREIRA AND BRADING

STILL PENDING ON WRIT OF HABEAS CORPUS TO U. S. SUPREME COURT, AND COURT MAY ACT

ON WRIT PRIOR TO JUNE 15, 1953. IF USSC DENIES WRIT, DEPARTMENT WILL ADVISE AS TO WHETHER BUREAU TO ARREST SUBJECTS. BUREAU HAS INSTRUCTED THAT ALL OFFICES MAKE PERIODIC SPOT CHECKS TO KEEP ADVISED OF SUBJECTS CURRENT WHEREABOUTS. DENIER FILES REFLECT THAT IN SUMMER OF 1952, PERKIRA'S WIFE, MRS. LEE LITT LE PERKIRA WAS USING 7501 TURTLE CREEK BLVD., DALLAS, AND 200 BURNETT ST., FT. WORTH, AS RESIDENCE ADDRESSES IN TEXAS. SUGGEST DALLAS DISCRETELY DETERMINE IF SUBJECT BRADING IN DALLAS OR FORT WORTH AND ADVISE INTERESTED OFFICES. MIAMI HAS REPORTED SUBJECT'S HAVE BEEN DRIVING LATE MODEL BLACK CADILLAC SEDAN, 1953 TEXAS LICENSE C/Y NINE NINE SIX NINE. DALLAS CHECK REGISTRATION THIS LICENSE AND NOTIFY INTERESTED OFFICES.
