BUREAU ADVISED THAT BY AIRTEL DATED 6-29-53, DENVER OFFICE  
ADVISED AS FOLLOWS: "DAVID R. GRAY, GRAY MOVING AND STORAGE  
CO., DENVER, REPORTED TODAY HE RECEIVED PHONE CALL FROM VICTOR  
PEREIRA REQUESTING PEREIRA'S PERSONAL AND HOUSEHOLD EFFECTS BE  
SHIPPED IMMEDIATELY TO 442A ROXBURY DRIVE, BEVERLY HILLS,  
CALIF. WHERE PEREIRA HAS PURCHASED A HOUSE OR LEASED ONE.  
PEREIRA SAID HE IS TEMPORARILY STAYING AT BEVERLY HILLS, CALIF.  
EL PASO MAY DESIRE TO FURNISH LOS ANGELES BACKGROUND INFORMATION  
THIS CASE SINCE PEREIRA APPARENTLY PLANS TO BE IN L.A. AREA  
INDEFINITELY." PERTINENT BACKGROUND INFORMATION RE THIS CASE  
BEING FURNISHED LA OFFICE IMMEDIATELY, AT WHICH TIME BUREAU  
INSTRUCTIONS IN THIS REGARD WILL BE FURNISHED LA.
