NY is continuing to be alert to possible violations
of Federal or local laws by the subject. Approximately two
months ago the NYCPD questioned DE MEO regarding some
ammunition which had been hijacked from one of the New
England states but results were unproductive.

It is not being recommended that the subject be
reinterviewed at this time inasmuch as he has lied to SAS
in the past and shows signs at this time of changing his
attitude.
