## ADMINISTRATIVE

Since there has been no indication that subject has been in the Cleveland area and since CV 428-C has ascertained that BAPST's relationship with DOMINICK EDWARD BARTONE is reportedly in connection with importing sugar from Cuba, transshipped to the United States through another island, no further inquiries concerning subject will be made at this time at Cleveland in order to avoid the possibility of compromising CV 428-C.

It is noted that in the report of SA STAFFORD dated December 30, 1960 at Miami, it was reported that subject indicated he had gone to the Dominican Republic to see an official on a "sugar deal".
