ADMINISTRATIVE

The Bureau is advised that the allegation that the subject was to bomb Ciudad Trujillo or San Isidro Air Base, Dominican Republic, as reported in CIA communication to the Bureau on 10/1/59, was not reported in the details of this report inasmuch as the State Department on 10/2/59, advised the Bureau that the allegation was "unfounded rumor and was nothing to it."

The Bureau is further advised that U. S. Customs, Miami, was advised of the above.

No communication is being prepared by the Miami Office requesting the Bureau to have appropriate investigation conducted in the Dominican Republic Fine the subject's whereabouts is not definitely known and his possible presence in the Dominican Republic is based on conjecture. The decision to request appropriate investigation in the Dominican Republic is being left for consideration by the office of origin (a)
