ANYTHING TO FURTHER EMBRASS US GOVERNMENT. STATES HE MADE ONLY ABOVE FLIGHT AND KNOWS NOTHING RE ALLEGED LEAFLETS BEING DROPPED SINCE. FOLLOWING ARE INCIDENTS REPORTED BY MM 639-S TENDING TO SHOW DESTRE AND ATTEMPTS OF CASTRO GOVERNMENT TO DISCREDIT US THROUGH CASTRO GOVERNMENT ENGINEERED AND PLANNED INCIDENTS. NO CONDITIONS SHOULD ANY OF FOLLOWING BE RELEASED TO PRESS NO CONDITIONS SHOULD ANY OF FOLLOWING BE RELEASED TO PRESS. AS TO DO SO WOULD MOST CERTAINLY PLACE INFORMANT'S LEFE IN IMMEDIATE IF FURNISHED TO OUTSIDE AGENCIES, IT SHOULD BE DONE UNDER THESE CONDITIONS ONLY. SEPTEMBER 18, 1959, INFORMANT WENT TO HAVANA CUBA AND WAS MET AT AIRPORT BY FERNANDO COBA, SGT. CUBA POLICE. ON SEPTEMBER 19, 1959, COBA TOLD INFORMANT THAT CHIEF OF POLICE ALMELJERAS GAVE HIM \$1,000 TO GET RAFAEL DELIPTING TO CUBA. TT BEING NOTED BEL PINO PUBLICALLY INDICATED HIMSELA TO BE AN ANTI CASTRO LEADER AT MIAMI AND SUBSEQUENTLY WAS SÉIZED IN CUBA JULY 25, 1959, AFTER HIS AIRPLANE LANDED ON HIGHWAY OUTSIDE HAVANA COBA TOLD DEL PINO WHILE IN MIAMI HE WAS LOOKING FOR A PILOT TO FLY TO CUBA AND RETURN WITH ALIEN TO MIAMI. COULD SEIZE 20 MEN. HE SAID HE WANTED TO EFFECT THE SAME TYPE OF INCIDENT THAT WAS CARRIED OFF BY WILLIAM ALEXANDER MORGAN ON OR ABOUT AUGUST 8, 1959. SAME DATE INFORMANT, ALMEIJERAS, COBA AND THREE BODYGUARDS WENT TO RAUL CASTRO'S HEADQUARTERS WHERE RAULECASTRO CONFIRMED ALMEIJERAS PLAN FOR INFORMANT TO BRING AN INVASION GROUP INTO CUBA. RAUL SHOWED GREAT INTEREST IN THIS AND MADE ARRANGEMENTS WITH INFORMANT TO USE COBA AS HIS HAVANA CONTACT. DESIGNATED A PRIVATE AIRPORT FOR USE BY INFORMANT TO ENTER AND DEPART CUBA AND INFORMANT WAS FURNISHED AN ADDRESS TO BE USED IN

HAVANA AS A MAIL DROP. DURING THE SAME CONVERSATION ALMEIJERAS AND RAUL CASTRO EXHIBITED INTEREST IN THE POSSIBLITY OF THE ASSASSINATION OR KIDNAPPING OF ESTEBANAVENTURA, FORMER LT. COL CUBAN NATIONAL POLICE, IN EXILE MIAMI. SEPTEMBER 28, 1959. MM 639-S WAS IN CUBA AND MET WITH FERNANDO COBA AND EFIGENIO ALMEIJERAS CHIEF CUBAN NATIONAL POLICE. LATTER INDIVIDUALS IN CONVERSATION GAVE INDICATIONS THERE ARE CUBAN AGENTS IN MIAMI INVESTIGATION BATISTIANOS. ALMEIJERAS WAS CONSIDERING SENDING SOMEONE TO MIAMI EITHER ASSASSIANTE OR KIDNAP ESTEBAN VENTURA ALMEIJERAS UP TO THIS TIME HAD DENIED PERMISSION OF HIS PERSON BODYGUARDS TO CARRY OUT MISSION AGAINST VENTURA. ON OCTOBER 10. 1959 MM 639-S WAS IN HAVANA CUBA AND CONVERSED WITH EFIGENIO ALMEIJERAS WHO AGAIN DISCUSSED WITH INFORMANT HIS DESIRE THAT INFORMANT LEAD EXPEDITION FROM THE US TO CUBA AND AGAIN EXPRESSED A GREAT DESIRE TO SEIZE THIS EXPEDITION UPON ITS ARRIVAL IN CUERA. ON ABOUT OCTOBER 20, 1959, MM 639-S RECEIVED A TELEPHONE CALL FROM FERNANDO COBA WHO WAS CALLING FROM CUBA. COBA HAD PREVIOUSLY CALLED THE GREEN MANSIONS MOTEL IN AN EFFORT TO CONTACT LYNNABATR A MIAMI PILOT ENGAGED IN ALIEN SMUGGLING. BAIR HAD MOVED AND COULD NOT LOCATE HIM. COBA TOLD INFORMANT TO OFFER PROPOSITION TO BAIR WHICH WOULD INVOLVE DELIVERING EVEL TO ALPIZAR PEREZ CUBA. ALPIZAR FORMER CUBAN AIR FORCE PILOT, NOW ENGAGED AND GUN SMUGGLING AND WORKING FOR ROLANDO MASFERRER, FORMER CURAN. SENATOR RESIDING IN MIAMI. THIS WOULD BE SAME SITUATION AS WHEN COBA DELIVERED DEL PINO. COBA OFFERED THIS ASSIGNMENT TO INFORMANT.

PAGE SIX FROM SAC, MIAMI 251030 WHO DECLINED. ON EVENING OCTOBER 24 MM 639-S ADVISED HE HAD JUST RETURNED MIAMI FROM HAVANA, CUBA HAVING ARRIVED THERE OCTOBER 23 IN COMPANY WITH ALEX HERNANDEZ, CUBAN RESIDING MIAMI WITH WHOM INFORMANT ASSOCIATES. INFORMANT AND HERNANDEZ HAD CONFERENCE OCTOBER 23 WITH EFIGENIO ALMEIJEIRAS, CHIEF CUBAN NATIONAL POLICE, HAVANA, AND FRANCISCO COBA, SERGEANT IN CUBAN POLICE. ALMEIJEIRAS PROPOSED TO INFORMANT THAT HE APPROACH FROMER CUBAN SEANTOR ROLANDO MASFERRER OR SOME OTHER ANT! CASTRO LEADER OF PROMINENCE IN MIAMI, AND OFFER TO PILOT A BOMB CARRYING PLANE FROM MIAMI TO CUBA FOR PURPOSE BOMBING HAVANA. THAT INFOR-MANT SHOULD CONTINUE TO PROCURE BOMBS WITH US GOVERNMENT MARKINGS AND UPON ARRIVAL IN CUBA MAKE LANDING ON STRIP 25 MILES WEST OF HAVANA WHERE BOMBS WILL BE TURNED OVER TO ALMEIJEIRAS. GOVERNMENT WILL THEN MAKE PRESS RELEASE CLAIMING THAT MIAMI BASED PLANE DROPPED BOMBS OVER CUBA AND WILL OFFER AS PROOF ONE OR MORE BOMBS BEARING US MARKINGS WHICH THEY WILL CLAIM WERE DUDS. BOMBS WILL BE EXPLODED AND FRAGMENTS OF SAME OFFERED AS ADDITIONAL NPROOF. ALMEIJEIRAS DISCLOSED THAT PURPOSE OF THIS HOAX IS FOR PROPAGANDA AGAINST US STATE DEPARTMENT IN ORDER TO FORCE US ACTION AGAINST ANTI CASTRO EXILES RESIDING IN US. ALMEJEIRAS DESIRED THIS PLAN TAKE PLACE OCTOBER 26 AND HE DESCRIBED IT AS BEING HIGHLY IMPORTANT TO CUBAN GOVERNMENT. ALMEIJEIRAS ALSO TOLD INFORMANT THAT SEVERAL HAND GRENADES WERE DROPPED BY LEAFLET DROPPING TWO ENGINED PLANE WHICH FLEW OVER HAVANA OCTOBER 21 LAST. HE SAID THAT ANOTHER PLANE FLEW OVER HAVANA SAME EVENING. BUT GUBAN GOVERNMENT DID NOT POSESS DESCRIPTIVE DATA.
