Five individuals, all Cuban refugees, now residing in the Continental United States and Puerto Rico, have now been interviewed and have each given statements which indicate that subject was believed to have been connected with Cuban G-2 in Cuba. PINO was interviewed on 3/11/64, and stated he had been in favor of CASTRO until early 1959, when he became disillusioned and fled Cuba in January, 1962. He denied working for G-2 and said he had been a member of an anti-Castro organization in Cuba. He also claimed membership in the anti-Castro organization, Second National Front of the Escambray (SNFE), in Dallas. He was again interviewed on 4/21/64, and again denied having been connected with Cuban G-2. He also denied admitting to either ~~CABOS~~ RICARDO or CALDEVILLA that he had been so connected. PSI MANUEL RODRIGUEZ, who is president of SNFE at Dallas, has advised subject was a member of SNFE at Dallas. On 3/29/65, RODRIGUEZ stated PINO was no longer active in SNFE. DANIEL FLORES, foreman, El Chico Restaurant Warehouse, 141 Howell Street, advised 6/8/65, PINO is still employed by this concern and resides at 4238 McKinney, Dallas, Texas. *no l am*
