Re New York letter to Bureau, 8/11/66.

On 9/14/66, MM [1115] furnished the following background information regarding subject to SA JOHN E. MC HUGH.

Informant advised that DELGADO left Cuba in 1960, as a political exile. DELGADO's father, now deceased, was an attorney and notary public in Havana. His mother, ELA AGUIAR, is still in Cuba and is a member of Accion Catolica (Catholic Action), a passive anti-CASTRO organization. ~~SECRET~~ (u)

DELGADO's wife is from the FALLA family, one of Cuba's wealthiest families. His wife's grandmother is ADELAIDA FALLA BONET, and his wife is the daughter of LAUREANO FALLA, who held vast sugar holdings in Cuba prior to the advent of CASTRO. Cuba

DELGADO attended elementary school and high school at LaSalle Christian Brothers, Vedado, Havana, and attended the University of Havana. He has two brothers in the United States, one of whom is EDUARDO DELGADO, a single medical doctor practicing in Miami. The name of DELGADO's other brother is unknown to the source but he is known to be married to the daughter of ERNESTO FREYRE, active member of Representacion Cubana en Exilio (RACE) and is the widow of ALFREDO CERVANTES who participated in the Bay of Pigs invasion and died after being captured and transported to Havana. ~~SECRET~~ (u) Cuba

Subject's wife also has a cousin, LAUREANO BATISTA FALLA, who is an active member of Movimiento Democratico Cristiano (MDC). Cuba
