On 3/2/72, he filed an application for permit to reenter the United States. He planned to leave on 3/25/72, from Miami via Panama to Venezuela on vacation.

This file reflected that INTERIAN was born 9/15/27, Havana, Cuba.

During the course of previous investigation regarding the organization Frente de Integracion Nacionalista (FIN), MM 2867-S reported that more than a year ago, INTERIAN gave instructions on the manufacture of bombs to several members of FIN and that INTERIAN had in his possession an accumulation of written material on the construction of bombs. INTERIAN was described by MM 2867-S as a technician and not a political-type revolutionary. (u)

MM 2867-S has been contacted at frequent intervals, the last time being on 2/21/74, at which time he possessed no recent information indicating that INTERIAN has given any instructions on the subject of bombings or has manufactured any bombs or been involved in any bombings on behalf of FIN or any other organization. (u)

On 12/13/73, MM 1550-KS, who is knowledgeable concerning some Cubans dealing in explosives, advised that his last contact with INTERIAN occurred during the early 1960s when he met INTERIAN through ORLANDO BOSCH AVILA, FIA, who was convicted on bombing charges in 1968 but who is now out on parole. Cuba

MM 1550-KS has advised during recent contacts that he has no knowledge of any current involvement by INTERIAN in explosives nor any contact by INTERIAN with BOSCH or other known suspected bombers.

(u) [On 12/6/73, MM 1337-S advised] that he possesses no information whatsoever concerning INTERIAN and has never seen him in contact with BOSCH or other suspected bombers.

It is to be noted that FIN, mentioned above, is an anti-Castro organization headquartered in Miami, which
