FROM SUPPORTERS OF SUBJECT THAT HE APPARENTLY CONTEMPLATED
SENDING MEN FROM MIAMI AREA TO TRAINING CAMP ON ISLAND IN BAHAMAS
DESCRIBED AS TWENTY KILOMETERS LONG, NOT FURTHER IDENTIFIED.

INDIVIDUALS RESIDING SIXTEEN FIFTYONE W. FLAGLER ST., MIAMI
AMERICANS AND CUBAN EXILES, REPORTEDLY PLAN JOIN MASFERRER-S
GROUP. SUBJECT AND OTHERS REPORTEDLY INVOLVED IN THEFT SIX
CASES DYNAMITE FROM CONSTRUCTION CO. MIAMI AREA., FROM WHICH
HUGHES BELIEVED TO HAVE MADE BOMBS MENTIONED IN RETAL.
