On 1/4/61, PSI under development MODESTO DIAZ MARON advised as follows: On 1/3/61, the Miami PD visited the home of subject and ordered him to cease maintenance and operation of a barracks at 1651 Flagler St., Miami. Police threatened to arrest the occupants in the barracks if they were not gone within 48 hours. MASFERRER thereafter contacted General MANUEL BENITEZ, Head of anti-CASTRO organization Unidad Pinarena, which maintains an office in a rented house at 23rd Avenue and Flagler Street, Miami. MASFERRER made arrangements with BENITEZ to allow the seven Americans residing at MASFERRER's barracks to move into the house rented by BENITEZ.
