SERGIO SANJENIS CABARROCAS, et al NEUTRALITY MATTERS

Re Miami airtel 9/30/59 and Bulet 10/12/59.

HUGO GONZALEZ LAJONCHERE on November 17, 1959, advised he had been in touch with SERGIO SANJENIS CABARROCAS and explained to SANJENIS that ROLANDO MASFERRER desired to have SANJENIS contact him. GONZALEZ LAJONCHERE stated he had informed SANJENIS concerning MASFERRER's desires and that SANJENIS did intend to contact MASFERRER. GONZALEZ LAJONCHERE pointed out that he believes that SANJENIS definitely will not partake of any counterrevolutionary plot in which MASFERRER is involved. GONZALEZ LAJONCHERE stated that it was his belief that SANJENIS might give some indication to MASFERRER of cooperating with him but that he doubted very much whether SANJENIS would become involved in any counterrevolutionary movement headed by MASFERRER. GONZALEZ LAJONCHERE stated, however, that he did not belief that SANJENIS would inform Cuban authorities concerning anything he might learn from MASFERRER.
