Re: Alleged Invasion of Cuba to be Headed  
by Rolando Masferrer, January, 1960

NY T-1 advised on December 16, 1959, that Dr. Rafael Guas Inclan, the former Vice President of Cuba under the Batista regime, had recently arrived in Miami, Florida, from Mexico. NY T-1 advised that the December 8, 1959 issue of "Cuba Libre," an anti-Castro paper published in Miami, carried an item welcoming Dr. Guas Inclan to Miami. NY T-1 stated that Dr. Guas Inclan is very ill and he doubts whether he is involved in any counter-revolutionary plans. NY T-1 stated he had no knowledge of the activities of Rolando Masferrer, but he had learned that Masferrer had desired to contact Alfredo Hernandez Valdes, the former Cuban Consul General in New York City.
