SAC Teague advised that Holloman, as a representative of the Dade County Sheriff's Office, met with subjects Valdez and Fernandez at the Airport Hotel, Miami, from 7:47 PM to 8:16 PM, 1-27-60, during which time Valdez and Fernandez propositioned Holloman for assistance in the kidnaping of Rolando Masferrer Rojas, former Cuban Senator, and offered \$25,000 for successful kidnaping. Subjects indicated the plot would be carried out at a later date and that payment would be 2843 PMV/ BALONS made after kidnaping and after Masferrer was back in Cuba.
