DETAILS:

On August 22, 1975, MMT-4 stated/that he is a close personal friend of ARMANDO LACASA, who was a candidate for the position of Director of the Cuban Refugee Program. He stated that it is commonly mentioned in the Miami Cuban community that RICARDO NUNEZ paid \$100,000 to JOSE MANUEL CAEANOVA, head of the Cuban Republican Party in Miami, for the position of Director of the Cuban Refugee Program. As the source heard it, the money, in turn, was delivered to FERNANDO DE BACA, Presidential Counselor.

The source was questioned for the specific source of the aforementioned allegation. According to the source, this information is commonly discussed in the Cuban area of Niami, including groups on the streets and in offices and shops and so forth.

The source said it is the same disgraceful practice that took place in Cuba; that is buying positions before CASTRO took over. He further commented that this appointment amounted to a license to steal; such being the
