Re Miami letter to Bureau dated 4/12/66.

Paragraph two of Bulet to Miami dated 1/7/66 points out that information from Bureau informant 200 should not be disseminated; therefore, no information concerning the subject is being submitted in report form or by LHM.

Miami believes that there is no need for additional investigation and this case is being closed.

The following information is set out:

FD 9 forms submitted for both subject and JOSE IGNACIO SOLIS REVUELTA showed no record identifiable for the two.

(C) MM [1115-S] advised on April 14, 1966 the following:

JULIA REVUELTA is married to ~~JOSE IGNACIO SOLIS~~. They have a son about 40 years of age named ~~JOSE IGNACIO SOLIS Y REVUELTA~~. The son was in the Cuban Army when CARLOS PRIO SOCARRAS was the president. There has been no indication that he was pro-CASTRO and in the past he had demonstrated a liking for the finer things in life. His father, JOSE IGNACIO SOLIS, was the press representative of the Cuban newspaper "Diario de la Marina" to the National Palace. His father was a lawyer by profession but had been the press representative for about 30 years under RAMON GRAU SAN MARTIN, CARLOS PRIO SOCARRAS and FULGENCIO BATISTA. JOSE IGNACIO SOLIS was related to ~~JOSE IGNACIO RIVERO~~, director and editor of the "Diario de la Marina." He is also related to JOAQUIN ~~GODOY~~, who is in Miami at the present time and active in anti-CASTRO activities. JULIA REVUELTA, who entered the United States via Mexico, about a year ago, is a sick woman.

MM 723-S advised the following on May 23, 1966:

On May 23, 1966, a conversation was had with JOAQUIN GODOY to the effect that he has a relative studying in Russia. GODOY said that a second cousin of his has a son from a previous marriage who is in Russia studying. He named the boy as JOSE ~~IGNACIO SOLIS~~ and that he is the son to JOSE IGNACIO SOLIS who resides in Miami and whose former wife still resides in Cuba.

The boy is about 12-14 years of age. He said that even though the son is in Russia, the father is not pro-Russia or pro-CASTRO.

JOAQUIN GODOY is one of the leading anti-CASTRO individuals in the Miami area.

The following informants who are also familiar with some pro and anti-CASTRO activities in the Miami area, were unable to furnish any information concerning the subject or other members of her family:
