Enclosed herewith are 11 copies of a letterhead memorandum setting forth information concerning above captioned subject matter.

NY T-1 mentioned in enclosed memorandum is NY 3248-PSI.

NY T-2 mentioned in enclosed memorandum is ERNESTO ARAGON, 233 East 69th Street, NYC, who is secretary to Dr. JOSE MIRO CARDONA. ARAGON was in Washington with Dr. MIRO from 9/5 to 9/15/61 and had several meetings at the White House with RICHARD N. GOODWIN and advisors to President JOHN F. KENNEDY. ARAGON, on 9/19/61, advised that during one of his meetings with GOODWIN at the White House, they were interrupted by Miss SCHIMER (ph), secretary to GOODWIN, who advised that JOAQUIN wanted to speak to GOODWIN. ARAGON stated that from listening to GOODWIN's portion of the conversation he knew that JOAQUIN was JOAQUIN GODOY of the MRP. He ascertained that GOODWIN has authorized furnishing all material and financial assistance to the MRP and after GOODWIN's conversation with GODOY, ARAGON told GOODWIN that this was what the Revolutionary Council complained about, namely, that people within the United States were dealing with various organizations and among the Cubans there was no central authority and since this was the situation, he saw no reason why the MRP or any other anti-CASTRO group should join the Revolutionary Council. ARAGON said that GOODWIN told him that this was an operation which had been started more than a month ago and could not be stopped at this time as it pertained to underground activity in Cuba.
