RE: EJERCITO LIBERTADOR CUBANO (CUBAN LIBERATING ARMY)(ELC) INTERNAL SECURITY - CUBA

The Ejercito Libertador Cubano (ELC) was formed in 1968 by members of the Asociacion de Veteranos de Bahia de Cochinos, Brigada 2506 (1982) (ESSOCIAtion of Veterans of the Bay of Pigs, Brigade 2506). The purpose of the organizers of the ELC was to attract to its membership the militant Cubans of other exile organizations and to unite under the banner of the ELC. They were attempting to develop a policy of positive military action against the Government of Cuba. After developing considerable interest among Cuban exiles and raising funds, the ELC was disrupted by internal dissension and allegations of misappropriation of the funds. As of January, 1969, the ELC was no longer active.

On January 30, 1969, <u>MARCOS VALDES CASTILLA</u>, then residing at the <u>Sylvania Hotel</u>, <u>226 Southwest Fifth</u> <u>Avenue</u>, <u>Miami</u>, Florida, was interviewed and advised that he had been an active <u>member of the ELC</u> and that he was not aware of any plans on the part of the ELC to conduct any militant activities. VALDES said that as of that time, the ELC was inactive and had closed its office.

On August 22, 1969, MM T-1, who is familiar with both pro and anti-CASTRO activities in the Miami area, advised that the ELC, which he described as the military arm of the AVBC, which had been inactive since the fall of 1968, had been reactivated under the leadership of LUIS TORNES. A meeting of the ELC was held at an office

an intense exchange of fire with the communists guarding the installation and with sailors on a boat patrolling the shore, the commando group was able to retire, having achieved its objective and without injuries. The release was signed by <u>Dr. ARMANDO FERNANDEZ</u>, <u>Venezuelan</u> delegate of the Ejercito Libertador Cubano, at Caracas, Venezuela, August 21, 1969. The release also contained a notation that additional details of this action would be given at a press conference which would be held in the city of New York by one of the leaders of the ELC, LUIS TORNES.

On August 28, 1969, MM T-3, a Cuban who is acquainted with the leaders of the principal anti-CASTRO organizations in the Miami area, advised that on August 23, 1969, LUIS TORNES, in a confidential conversation, remarked that he was connected with the "Cubau Liberation Army" and that he had practically separated from the leadership of the AVBC, which had originally started the ELC. TORNES said that secret cells of the ELC were being created in order to carry out operations abroad as well as inside the United States. He said that he was leaving for New York City, where he would hold a press conference in connection with the recent attack on Cuba and at the same time work on preparing the secret commandos who will operate in the United States.

On August 25, 1969, MM T-4, a Cuban who has been involved in revolutionary activities during the past eleven years, advised that with regard to the claim by LUIS TORNES and the ELC that they had recently made a raid on <u>Cuba</u> and had engaged a Cuban patrol boat, he had discussed this with <u>FRANCISCO RODRIGUEZ TAMAYO</u>, a close associate of LUIS TORNES. RODRIGUEZ stated that this report by TORNES was a fabrication which TORNES was using to justify the money which he has been collection from Cuban businessmen in the Miami area.

On August 29, 1969, MM T-1 reported that he had attended a meeting of the ELC on August 28, 1969, at the office of the organization located at 1878 West Flagler Street, Miami. JOSE M. MACIAS was present at this meeting and he admitted confidentially that although he had been among those who had previously claimed that he had participated in the attack on Cuba on August 18, 1969, in
