The Bureau's attention is invited to instant LHM which was furnished on a voluntary basis by MM [815]-S It is known to SA EDWIN L. SWEET that JORGE ROBRENO MARIEJES was one of the very well known, and very well hated collaborators of the Castro Regime. He is A HAS NO OBJECTION TO puppet who would have sentenced his own mother to ECLASSISICATION AND/OR, death if he thought he could have advanced in theRELEASE OF CIA INFORMATION Castro Government. IN THIS DOCUMENT.

The same is true of the attorney, Dr. PELAYO K 12-15-9 FERNANDEZ RUBIO CARDOSO, who is known by the nickname of "Pool of Blood" (Charco de Sangre) and was the prosecutor at the trial of WILLIAM A. MORGAN as well as numerous other individuals who in 1960 and 1961 began to openly oppose the Castro Regime.

It is suggested that instant LHM be called the attention of the State Department and that it be furnished to the Consulate in Madrid with a request that ROBRENO MARIEJES be interrogated thoroughly concerning his activities as a member of the revolutionary military tribunals before he is issued any visa to come to the U.S.
