The Bureau's attention is invited to instant LHM which was furnished on a voluntary basis by ~~MM [815-S]~~ (S). It is known to SA EDWIN L. SWEET that JORGE ROBRENO MARIEJES was one of the very well known, and very well hated, collaborators of the Castro Regime. He is a puppet who would have sentenced his own mother to death if he thought he could have advanced in the Castro Government.

IN THIS DOCUMENT.

The same is true of the attorney, Dr. Pelayo FERNANDEZ RUBIO CARDOSO, who is known by the nickname of "Pool of Blood" (Charco de Sangre) and was the prosecutor at the trial of WILLIAM A. MORGAN as well as numerous other individuals who in 1960 and 1961 began to openly oppose the Castro Regime.
