RE MIAMI AIRTEL TO BUREAU, JULY 10, 1974.

ON JULY 8, 1974, MM 974-S REPORTED THAT ORLANDO BOSCH AVILA WAS HIDING OUT IN MIAMI AND THAT RAUL BARANDELA ESTEVEZ WAS BROUGHT TO MIAMI BY BOSCH'S FRIEND MAX LESNICK PUBLISHER OF "REPLICA", MIAMI, FOR PURPOSE OF GIVING PROTECTION TO BOSCH. (u)

ON JULY 19, 1974, MM 1550-KS REPORTED THAT EUGINO "NINO" DIAZ, CUBAN EXILE, FORMERLY ACTIVE IN CUBAN REVOLUTIONARY TYPE MATTERS IN MIAMI, DISCLOSED THAT RAUL BARANDELA RECENTLY TOOK BOSCH TO PUERTO RICO WHERE HE ALLEGEDLY REMAINS AT THE PRESENT TIME.

MM 1550-KS ALSO LEARNED FROM A SOURCE CLOSE TO MAX LESNICK THAT BARANDELA IS IN POSSESSION OF SUITCASE LOADED WITH MONEY, AND IS ONE OF SEVERAL INDIVIDUALS RESPONSIBLE FOR
